#### What is the intended benefit of the rule?

To describe IEDA's policies and procedures to implement Iowa Code sections 15A.1 and 15.329(2).

## Is the benefit being achieved? Please provide evidence.

Yes, IEDA is able to collect the information required by sections 15A.1(3) "a" and 15.329(2) regarding violations of laws and evaluate whether applicants should receive financial assistance. IEDA is also able to comply with the requirement to collect documentation regarding solid and hazardous prior to disbursement of financial assistance as required by section 15A.1(3) "b".

#### What are the costs incurred by the public to comply with the rule?

Applicants for IEDA programs require staff time to generate reports of violations of law required by Iowa Code sections 15A.1 and 15.329(2) and provide documentation regarding solid and hazardous waste. Some businesses may also choose to rely on an external service provider, such as an attorney, to generate the reports. The amount of the costs will vary, depending on the compensation of such staff or service provider. Minimal time is required to complete the required documentation.

#### What are the costs to the agency or any other agency to implement/enforce the rule?

IEDA staff time is required review and evaluate reports of violations of laws and to obtain solid and hazardous waste information.

Yes. Only businesses that will potentially benefit from IEDA programs incur any costs to comply with the rules. The costs to the IEDA to evaluate the information collected are minimal.
