Roll call vote was taken. Voting aye: Davin Hills, Hank Norem, Donna Ramaeker Zahn, Emily Harris, Rich Hichwa and Pankaj Monga. Voting Nay: Kathy Zehr. Motion carried.

Roll call vote was taken. Pankaj Monga and Emily Harris were not present when the vote was taken. Motion carried unanimously of all members present.

Higher Learning Technologies - Coralville

MOTION: Hank Norem moved that the TCC recommend that the Iowa Economic Development Authority Board approve a \$400,000 Innovation Acceleration Expansion Fund award to be repaid through loan payments with terms as follows: the award amount paid back at an interest rate of 3%, a 5-year loan term, and a 6-month deferral, with release of funds contingent upon repayment of Propel loan balance within 60 days and provided that repayment in full of expansion loan is required upon closing of subsequent funding round, seconded by Davin Hills. Roll call vote was taken. Voting aye: Davin Hills, Hank Norem, Rich Hichwa and Kathy Zehr. Voting Nay: Donna Ramaeker Zahn. Pankaj Monga and Emily Harris were not present when the vote was taken.
