MOTION: Donna Ramaeker Zahn moved that the TCC recommend that the Iowa Economic Development Authority Board deny the application for a \$100,000 Demonstration Fund award and approve a \$25,000 Investigative Proof of Commercial Relevance (IPOCR) award to be repaid through royalty payments with terms as follows: repayment amount is \$25,000 paid back at 3% of calendar year total gross revenue, which does not include grant funds, with each payment due June 1 of the following calendar year, seconded by Rich Hichwa. Roll call vote was taken. Motion carried unanimously.

Qi Learning - Ames

MOTION: Rich Hichwa moved that the TCC recommend that the Iowa Economic Development Authority Board deny the application for a \$100,000 Demonstration Fund award and approve a \$25,000 Proof of Commercial Relevance (POCR) award to be repaid through royalty payments with terms as follows: repayment amount is \$25,000 paid back at 3% of calendar year total gross revenue, which does not include grant funds, with each payment due June 1 of the following calendar year, seconded by Davin Hills. Roll call vote was taken. Motion carried unanimously.

Roll call vote was taken. Pankaj Monga was not present when the vote was taken. Motion carried unanimously of all members present.

MOTION: Davin Hills moved that the TCC recommend that the Iowa Economic Development Authority Board approve a \$250,000 Innovation Acceleration Propel award to be repaid through loan payments with terms as follows: the award amount paid back at an interest rate of 3%, a 5-year loan term, and a 6-month deferral, with release of funds contingent upon repayment of Demonstration Fund loan balance within 60 days of the award date, provided that repayment in full is required upon closing a funding round of \$2 million or more, seconded by Rich Hichwa. Roll call vote was taken. Pankaj Monga was not present when the vote was taken. Motion carried unanimously of all members present.

Tractor Zoom - Urbandale

MOTION: Hank Norem moved that the TCC recommend that the Iowa Economic Development Authority Board approve a \$250,000 Innovation Acceleration Propel award to be repaid through loan payments with terms as follows: the award amount paid back at an interest rate of 3%, a 5-year loan term, and a 6-month deferral, with release of funds contingent upon repayment of POCR and Demonstration Fund loan balances within 60 days of the award date, provided that repayment in full is required upon closing a funding round of \$2 million or more, seconded by Donna Ramaeker Zahn. Roll call vote was taken. Pankaj Monga was not present when the vote was taken. Motion carried unanimously of all members present.

Innovative Lighting - Des Moines

<u>MOTION</u>: Davin Hills moved that the TCC recommend that the Iowa Economic Development Authority Board approve the request to subordinate IEDA's UCC-1 filing position to new lender, which has made it a condition of refinancing debt remaining after a portion of the company was sold, seconded by Emily Harris. Roll call vote was taken. Pankaj Monga was not present when the vote was taken. Motion carried unanimously of all members present.
