

Butchery Innovation and Revitalization Program: Application Checklist

Application Instructions

All relevant information below available on IEDA Butchery Innovation website

- 1. Before starting the IEDA application process, ensure you have completed the CIRAS Assessment.
 - Deadline to submit CIRAS Assessment is November 28, 2022. Allow up to 72 hours to start Assessment process.
 - Refer to the CIRAS Assessment Sample Form
- 2. Review Iowa Code section 15E.370 and 261 Iowa Administrative Code Chapter 51.
- 3. Deadline for submitting IEDA Butchery Grant Program application is Noon/12 p.m. on December 21, 2022.
- 4. Refer to the FAQ and the IEDA Butchery Grant Sample Form.
- 5. Have all required documents available and ready for uploading in PDF format.
- **6.** The review and scoring process will be completed within 4-6 weeks, with announcements from IEDA Board approval planned in First Quarter 2023.

- Iowa Sales Tax Permit Number
- US DOT Number (if applicable)
- State of Incorporation and Date of Incorporation
 - If the business is incorporated in Iowa or authorized to do business in Iowa, this information may be available from the Iowa Secretary of State's website
- List of business' owners and percent ownership
- Number of employees at each location of the business
 - o Information will be verified with Iowa Workforce Development
- IDALS or USDA Establishment Number
 - Issued by the Iowa Department of Agriculture and Land Stewardship (IDALS) or USDA Food Safety and Inspection Services (FSIS)
 - Name of licensee, if different from the applicant
 - If the business is not licensed and currently working with IDALS or USDA to obtain licensure, information on agency/contact, etc. will be required
- Iowa Department of Inspections and Appeals License Number (if applicable)
 - o Name of licensee, if different from the applicant
- Iowa Alcoholic Beverages Division License Number (if applicable)
 - o Name of licensee, if different from the applicant
- Total projected budget and uses of funds (see Sample Table, page 2)
- Source of funds for the project and documentation of any commitments of those funds (see Attachments below)
- Wage-range estimates to be paid to any additional employees hired as part of the project

Attachments Required

Please have the following documents available in digital/PDF format to attach/upload with the application:

- · Verification for Matching Funds Source
 - o Documentation will be required to show funds are available to match the grant request, dollar-for-dollar.
 - o Examples include: Bank Loan, Balance Sheet, etc.
- If federally inspected, a copy of the most recent Grant Inspection Form (FSIS Form 5200)
- A business plan or marketing plan, if available.
